Managed lanes definition









By Vehicle Type

- Transit-only lanes
- Truck-only lanes

By Occupancy

 High Occupancy Vehicle (HOV) or carpool lane

By Time of Day

- Reversible lanes
- Part-time shoulder use

By Toll

- High Occupancy Toll (HOT) lane
- Express lane

Types of toll lanes




HOT Lanes

- High-occupancy vehicles are free (typically 2+ or 3+)
- Single-occupancy vehicles pay a toll

Express Lane

- All passenger vehicles pay a toll to use
- Typically high-occupancy vehicles receive a discount



- Improve person throughput
- Support goods movement
- Improve modality and travel reliability

Project Management

- Caltrans District 3
- Yolo TD

Funding

- Committed: \$97 million
 - INFRA: \$86 million
- Project Cost: \$230-\$465 million

Project schedule

Environmental

- Draft environmental document released: November 13, 2023
- Comments due: January 12, 2024
- Final environmental document: March 2024

Design


Design complete: Summer 2024

Construction

- INFRA deadline: September 2024
- Construction start: Fall 2024
- Construction time: 2-3 years depending on the alternative



Toll revenue and expenditures



Additional impacts to gross and net toll revenue

- Toll prices and operating hours
- Discount programs
- Required mitigation

Revenue generation factors

- Toll facility length
- Direct connectors
- Dual-lane facilities

AB 194 tolling authority process

Project Application

- 60+ page report including appendices
- Predefined sections based on requirements
- Must be submitted by the entity requesting tolling authority

Public Hearing

- Arranged by CTC staff
- Must be located near project
- Must occur prior to CTC commission meeting to consider application

CTC Decision

- Information item with presentation by applicant
- Action item with presentation by CTC staff
- Anticipated March 21-22, 2024

Caltrans' role in the JPA


- Lack of clarity on voting role


