1) TCC Coordination (All, 15-minutes)

- a. Brief introductions and sharing of significant news about transit systems
 - SacRT highlighted the transition to a new microtransit service, SacRT Flex, whose focus will be on vulnerable
 populations. The new service will cost a fraction of SmaRT Ride, the existing microtransit service, while still
 accessible to at least half of existing riders. SacRT provided an update on competitive grants recently awarded
 to the agency, including to continue converting Blue and Gold Line stations to be accessible for low-floor trains,
 mobility hubs, and zero-emission bus facility.
 - Paratransit Inc. noted that its one-stop call center for regional transit information, MetroHub, is set to go live in early 2025.
 - The City of Sacramento noted funding received for Sacramento Valley Station, updates on the 8th Street protected bicycle track, and more.
 - Roseville Transit highlighted that its Comprehensive Operational Analysis (COA) was recently approved by the City's Transportation Commission.
- b. Update on Transit Asset and Grants Management Software (SaaS) vendor selection B2Gnow (Blackcat)

2) SACOG Blueprint 2025 Update (Holtzen, Conly/All, 30-minutes)

SACOG's Blueprint 2025 staff, Clint Holtzen and Darren Conly, provided an update on the effort, including a
refresher of the transit service assumptions baked into the plan and how the team incorporated regional transit
planning efforts like the Regional Transit Network (RTN), as well as input provided by the transit operators, into the
plan.



- SacRT noted its support for bus expansion in the plan as opposed to solely light rail. The agency is exploring Bus
 Rapid Transit (BRT) concepts to extend rapid transit along existing dedicated right-of-way on the Blue and Green
 Lines. SacRT noted that this does not preclude light rail from being implemented in the future, though it will be
 contingent on funding becoming available.
- SACOG staff noted that light rail extensions are included as amendment priorities in the Blueprint Transportation Project List should funding be identified. SacRT reiterated that light rail extensions are not feasible without additional federal, state, or local funding.
- SACOG staff noted that the Blueprint leans heavily on land use assumptions and financial constraint. Staff encouraged the transit operators to use the Blueprint as support for projects seeking competitive grant funding.
- SacRT noted that the plan assumes 30% service increases by 2035 from existing levels and 100% service increases by 2050. These assumptions will provide the foundation for support for service expansion efforts.
- Yuba-Sutter Transit highlighted that the assumed service expansions by 2035 and 2050 will be challenging due to the Innovative Clean Transit (ICT) zero-emission fleet transition rule that will require an increase in vehicle fleets even with existing service hours. The agency inquired whether these challenges will be highlighted in the narrative of the plan. SACOG staff noted these challenges will be included in the plan's narrative, along with an assumption that the state will provide additional funding to transit agencies to meet the ICT rule through a Road Usage Charge (RUC)/Vehicle Miles Traveled (VMT) fee which will replace the existing fuel-tax based system.
- SACOG staff noted that even with a RUC/VMT fee, along with more regional funding sources like managed lanes on the highway system, there is still not enough funding for all the region's capital needs.
- SacRT noted that the Transportation Project List is in PDF format which makes it difficult to sort projects. SACOG staff will distribute a sortable, spreadsheet version to the committee.
